1. Purpose of Contract

2. Inquiries

All inquiries must be in English or Spanish.

In case of not complying the stated above, inquiries can only be made by stating Full Name or Business Name, Address, Fax and email address, in which the inquiries will be received until the date of the bid's opening. Telephone inquiries will not be accepted, and the ones received out of term will not be answered.

Clarifying and modifying circulars for the paperwork may be prepared, in order to answer similar inquiries. These will be included as part of the Specific Terms and Conditions, and will be published in the Mission's website (www.eeoea.mrecic.gov.ar).

3. Notifications

- 5.5 The offer must contain the following information:

- 5.6 If the Offer is signed and presented by a legal representative, a copy of the power of attorney or the documents proving the representative's capacity to subscribe the proposal must be attached.

6. Vehicle Exhibition

The vehicle offered by the Mission will be exhibited in the place, date and time indicated in the 1st page of these specific terms and conditions.

The bidders / offerors acknowledge that, after presenting the offer, they had the opportunity to inspect the vehicle. If they decide to present an offer without performing a previous inspection, it is up to their own risk, in which no claim will be effective in regards to the items purchased, with reasons for the vices that may present.

The bidders irrevocably waive the right to invoke the guarantee for the redhibitory vices, in relation to the goods of the present contract.

7. Auction Celebration

On the time and date indicated above, the bids will be opened in a public ceremony, in the presence of the officials appointed for that purpose by the highest authority of the Mission, and of all those who wish to be present as witnesses. The Minutes will be prepared, to be signed by the officials involved, as well as by those bidders who are present and wish to sign.

If the day indicated for the opening of the bids becomes a non-business day, the act will take place the next business day, in the same place and time.

All offers presented in the timeframe stated will be considered in the opening of the bids. In case of any observations arise during the act, it will be recorded in the opening minutes for further analysis by the competent authority.

8. Verbal Bid

Two (2) business days after the date of the auction (opening of bids), a reading of all admissible offers that are considered as participating will be made.

Finalized the reading of all admissible offers, the bidders will be invited to improve their offer by a **VERBAL BID**, in which the offer with greater value will be selected.

A minute will be written stating the results of the auction, and it will be signed by all the appointed officials and the present bidders that wish to sign.

9. Vehicle expenses

The costs of transportation, freight, haulage, and any other expense or cost demanded by the fulfillment of the contract will be the exclusive responsibility of the highest bidder. Also, they will be responsible for the payment of the corresponding taxes, clearance cost, duties and customs services, and any other tax that affects the acquired property.

All the expenses of transfer of the vehicle delivered by the Mission will be part of the offered price and will be paid by the contractor.

To this end, the Mission will deliver the corresponding documentation so that it initiates the transfer procedures.

10. Traffic tickets and violations

The vehicle offered by the Mission is free from any ticket or traffic violation payment, at the moment of the handing over. The Mission will take over any payment cancellation of existing fines that are previous to the issuance of the SALE ORDER.

11. Damages

Once the vehicle offered by the Mission is acquired and picked up, the buyer will be exclusively responsible for any loss or damage caused to third parties, being at their expense any cost that occurs.

12. Validity of offers

Bidders are required to maintain the validity of their proposals for a period of thirty (30) calendar days from the date of the opening of bids.

This period shall be extended for equal periods without need for a request, unless the Bidder clearly declares unwillingness to renew the proposal, with a minimum of ten (10) days prior to the expiration of one of the extensions; in this case, the offer will be excluded from the procedure.

13. Award

The award will be given to the offer that meets all requirements and is the most advantageous to the Mission, taking into consideration the quality, the suitability of the bidder, and offers the highest price.

The award will be duly notified to the successful Bidder and the rest of the Bidders within THREE (3) business days after the award process, using any of the methods listed under "Notifications" of these Bid Specifications.

Within the next TEN (10) business days of notification of the award process, we will issue the SALES ORDER to the successful Bidder, and this will be notified by the same method mentioned above.
